**ENGAGEMENT OF FACULTY FOR RSETIs at
Lucknow and Barabanki Districts
DETAIL TERMS AND CONDITIONS**

For engagement of **FACULTY** at RSETI Lucknow and Barabanki the following terms and conditions to be read and followed by the applicant:

Eligibility for Faculty:

- Should be a graduate.
- Should have a flair for teaching and possess sound computer knowledge.

Desirable:

- i. 2 Years' experience as in-house Faculty or visiting faculty. Shall possess good flair/computing skills/knowledge in Computer etc.
- ii. Candidate should preferably be resident of local area.

Age Criteria:

Min. 25 years Max. 63 years subject to physical fitness.

How to apply:

Application should be submitted in Bank's prescribed format available in our bank's website. (Annx 1- For All Applicants, Annx-2 & Annx-3 additionally for retired employees of PSU banks)

Selection Procedure:

All candidates applying for the above post will have to clear:

- Written Test: To assess General Knowledge and computer capability
- Personal Interview: To assess communication ability, leadership quality, attitude, problem solving ability and ability to get along with the trainees development approach.
- Demonstration/Presentation- to assess teaching skill and communication capacity

Decision of bank in this regard will be final.

Contract Period:

The candidate shall be engaged on contract basis for a period of 2 years. Renewal may be considered at Bank's sole discretion in terms of extant policies and rules. The contract may be terminated by either side by giving one months notice. The contract will automatically terminate on acquiring of age of 65 years by the engaged faculty.

Remuneration:

The remuneration will be Rs.20,000/- per month.

Actual travelling expenses

Actual travelling expenses Max. Rs. 250/-per diem, for taking on the job training wherever required at site other than the institute, to be approved by RSETI in-charge/Director based on the reasonability of the same.

Handwritten signature

Leave:


- The candidate can avail leave for a maximum period of 12 days in a year apart from Sundays & Holidays, Max. 4 days on each occasion.
- There is no provision for encashment of leave even after exit of the faculty on any reason/ground. No leave can be accumulated at the end of the calendar year, the leave would lapse.

Last date for submission of application is 20.03.2017. **Soft copy of application will not be entertained.**

Kindly note that the candidates need to submit only 1 application for both centers.

The date of written test, personal interview and presentation will be decided after due consultation with higher authorities and committee for the same.

N.B. For retired Employees of PSU Bank extant provisions in vogue shall apply. In case of any dispute, jurisdiction of Lucknow only shall be valid.
